Recent Activity Regarding the Johnson Amendment in the U.S.

THE ASSOCIATION OF JUNIOR LEAGUES INTERNATIONAL, INC. Women building better communities*

In its response to the Advisory Resolution on Junior Leagues Not Endorsing Specific Candidates, which was adopted at the 2017 AJLI Annual Conference, the AJLI Board pledged to keep you updated and to take appropriate action. In the July 18 All League Email, AJLI reported recent legislative activity on the Johnson Amendment. Specifically, the U.S. House of Representatives Appropriations Committee approved a rider that would prevent the IRS from taking action against churches that violate the prohibition against direct participation in partisan electioneering.

Support for preserving the Johnson Amendment has grown to 4,800 national and local nonprofits, including several individual Junior Leagues. Support for preserving the Amendment also includes one hundred religious denominations and organizations, more than 3,000 religious leaders, houses of worship, and foundations and 72 percent of American voters. After careful consideration, and out of respect for the strong sentiment voiced by delegates at Annual Conference about keeping partisan politics out of nonprofits, the AJLI Board has decided to sign the letter of support developed by the National Council of Nonprofits.
